WITH 62 BEDS IN LOS ANGELES AND 18 BEDS IN THE BAY AREA, THE FOCUS OF THE CRISIS SHELTERS IS ON PROVIDING IMMEDIATE NEEDS SUCH AS A SAFE ENVIRONMENT, A WARM BED, FOOD AND CLOTHING. THIS ALLOWS A YOUTH THE CHANCE TO WORK WITH A CASE MANAGER IN CREATING A CASE PLAN THAT WILL HELP MOVE THEM TOWARD INDEPENDENT LIVING.

IN FISCAL YEAR 2016, COVENANT HOUSE CALIFORNIA SERVED 1,827 YOUTH.

OUR LOS ANGELES CAMPUS HAS 24 BEDS FOR THIS PROGRAM AND THE BAY AREA HAS 12. ADDITIONALLY, COVENANT HOUSE CALIFORNIA HAS FIVE OFF-SITE APARTMENTS THAT HOUSE 10 YOUTH WHO ARE IN THE FINAL STEPS OF LIVING INDEPENDENTLY. THE YOUTH PAY A PORTION OF THE RENT AND BILLS
